Thank you for choosing the PATPET U01 dvice.

The U01 is designed to let dogs live safely, happily and get along with people more harmoniously.

↑WARNING Do not use with aggressive dogs.

Aggressive dog's can cause severe injury and even death to their owner and others. If you are unsure whether this product is appropriate for your dog, please consult your veterinarian or certified trainer.

▲CAUTION Safety on-leash training.

It is vitally important that you and your dog remain safe while learning on-U01 training. Your dog should be on a strong leash, long enough for him to attempt to chase an object, but short enough for him not to reach a road or other unsafe area. You must also be physically strong enough to restrain your dog when he tries to chase.

WORK PRINCIPLES

This handheld ultrasonic bark control (device) is made with ultrasonic technology. When the dog barks, press the Ultrasonic emission button and the speaker will release ultrasonic sound to stimulate the dog and make him feel uncomfortable. After this is repeated for a few times, dog will learn that his barking will bring uncomfortable feeling to himself. By so, he will always think of this when he want to bark. This is a safe and effective way to stop barking.

HINTS AND TIPS


- Different dog breeds may react to the ultrasonic sound differently. For optimal results ,please use the product as a training aid, along other tools/commands. Be patient on this training process.
- Average human hearing frequency range is between 20Hz~20KHz, and dog can hear a wider range from 15Hz~120KHz. The product emits ultrasonic sound at 23KHz~27KHz. So the sound cannot be hear by human but can be hear by dogs.
- 3. Do not use the device against your ear for testing.
- This device can be used for bark deterrent training for dogs.
 Maximum operating range is 30 Ft.
- This device is not intended to provide protection against aggressive dogs.
- ${\bf 6.\ This\ device\ is\ not\ a\ toy,\ keep\ out\ of\ reach\ of\ children.}$
- 7. Do not submerse the unit in water or any other liquid.
- 8. If press and hold the button for 10 sec, the device will shut off.
- 9. If red light flashes, the device is low battery.


SCENARIOS




- A. Ultrasonic emission port

OPERATING INSTRUCTIONS

Install battery on the U01


- 1. Take out the battery cover from U01 (1A).
- Install the battery according to the engraved mark, negative (-) first, positive(+) next(1B-1,1B-2).
- 3. Push the battery cover in U01 (1C).
- ACAUTION 1. New and old alkaline batteries and Other batteries can not be mixed, can not recharging for the alkaline battery.
 - If the device has not been used for a long time, please remove the battery.



Function test

- Press the "Tone" button, the beep sounds and the green indicator light is on. Tone function is normal.
- 2. Place the test sheet vertically on the Ultrasonic emission port (2A). Test sheet placement direction (2B).

Press the "Ultrasonic emission" button, the test sheet will swing up and down and the red indicator light is on. Ultrasonic function is normal.



HOW TO USE

- 1. Hold the device in our hands.
- 2. Press the button when you hear the dog barks (max distance 30 Ft).
- Press the "Tone " button, the beep sounds and the green indicator light is on. Tone function is normal.
- 4. If press and hold the button for 10 sec, the device will shut off.
- 5. If red light flashes, the device is low battery.

Warranty and repair information

1-Year Limited Lifetime Warranty

The original purchaser for this unit is provided with 1-YEAR WARRANTY. The warranty begins from the date of purchase. For the first year, coverage is for both Parts and Labor on warranty repair services.

Accessories such as straps and batteries are covered for the first year only. After the first year, the Limited Lifetime Warranty covers Parts only and does not cover Labor Fees and Accessories. All shipping fees incurred, the cost of Accessories after the first year, and labor cost related to the repair work out of warranty, are the customer's responsibility. Labor cost will be variable depending on the work load. The limited lifetime warranty expires 5 years after a model ceased production.

To Qualify for the Warranty

A proof of purchase is required to initiate repair work for any models within warranty time. We strongly recommend customers to keep the original receipt. If the original receipt is not available, the production date of the unit will be judged by the

S/N (serial number) . S/N may differ from the actual purchasing date, is the only method of judging the approximate purchasing date with the purchase proof absent.

Not - Warranty Range

We DO NOT offer warranty for products that have been bought secondhand or as a resold product. We DO NOT replace defective units or provide refunds for products purchased from us after 30 days from the date of purchase. Issues of replacement and refunds on units purchased less than 30 days from an authorized dealer must be addressed to the dealer directly.
