





toy assembly

No assembly is required, just install the batteries, press the power button and place the multi laser light toy on the floor. Place the toy only on the flat, level floor and not on any other surface.

Inserting the battery

- 1. Remove the battery compartment cover on the bottom of the toy (A).
- 2. Insert 3 AA batteries into the battery compartment (B).
- 3. Replace the battery compartment cover and make sure it is properly closed.

Instructions for use The multi-laser

light toy rotates two laser lights in a 360-degree pattern for 15 minutes and then turns off automatically.

- Place the toy on the floor.
- To turn on the power (C) , press and release the power button on the side of the toy.
- The toy turns on, beeps and the laser lights flash three times.
- The toy switches off automatically after 15 minutes.
- If you want to end the play time before the toy turns off automatically, press the power button once.

To ensure proper functioning

- · Do not mix old and new batteries.
- Do not use standard batteries with alkaline batteries or rechargeable batteries.
- · Do not use rechargeable batteries.
- Used batteries should be removed immediately. Do not dispose of batteries with household waste.
