





QUICK START GUIDE

Press and hold the ① Power Button for 3 seconds to turn on Wicked Mouse.




Tips Wicked Mouse will play with your cat for 10 minutes, then it will rest for 30 minutes. The ③ Light Strip (Blink Tail) flashes yellow slowly under sleep mode. However, during the rest time, it can be re-activated by your cat's touch and play with your cat for another 10 minutes.

⚠️ Before having fun with your cat, please check that your Wicked Mouse's surface is in good condition.

⚠️ Supervision is required during the playtime to prevent your pet from swallowing.

HOW TO CHARGE



Tips 1. Press and hold the ① Power Button, if the ③ Light Strip (Blink Tail) is flashing red or there is no response, please charge your Wicked Mouse.

2. If Wicked Mouse stops moving and the ③ Light Strip (Blink Tail) is flashing red for 3 seconds while playing, Wicked Mouse runs out of power, please charge it.
